Basic fee is a fee that the Bank collects for one-off transactions effected with payments cards at POS devices of the Bank and for transactions with American Express cards effected at POS devices of other banks with which Intesa Sanpaolo Banka d.d BiH has concluded card acquiring agreements.

1.2. Commissions and fees for e-Commerce points of sale

V AGENT BUSINESS

1. Fee for the agent deals:

- **For the agent deals with repayment up to one year:**
- up to 2% one-off of the agent deal amount min. BAM 50.00 payable in advance, i.e. Prior to disbursement of funds under an agent deal, non-refundable in case of non-performance of a deal
- **For the agent deals with repayment over 1 year:**
- up to 2% one-off of the agent deal amount min. BAM 50.00 payable in advance, i.e. prior to disbursement of funds under an agent deal, non-refundable in case of non-performance of a deal + 0.2% of the debt balance under an agent deal, min, BAM 30.00 for every subsequent calendar year until expiry of the agent deal maturity date.

The fees include Bank costs related to calculation of interest and sending notices to the Borrower. If the Bank has also accepted a mortgage on behalf and for the account of the Lender for the agent deal, the Bank shall charge actual costs of a mortgage constitution. As a rule, the Bank shall charge the actual costs of the mortgage constitution from the Borrower if not arranged otherwise between the Borrower and the Lender.

2. Prolongation fee related to the previously concluded agent deal

- 1% one-off of the prolonged amount of the agent deal, min BAM 50.00 payable prior to signing an annex.
- Fees indicated in Article 1 and 2 of this Decision (item IV The AGENT DEALS) shall be collected by the Bank from the Lender or the Borrower as agreed between them subject to an agency agreement

3. Costs of monitoring non-performing agent loans

Costs of monitoring non-performing agent loans (loans being subject to legal actions) shall represent costs of the Bank related to handling of non-performing agent loans that result from a need for additional engagement of the Bank's resources (thus related to costs of gross salaries and other costs related to employment status of the Bank's staff) or external staff (or attorneys or other legal experts and costs related therein), as well as costs related to the use of other resources of the Bank (cost of paper, electricity, adds, mailing costs, and other costs incurred by the Bank as a result of performance of legal actions related to agent loans). Total monthly costs related to agent loans at the Bank level shall be allocated on flat sum basis across agent loan providers based on the number of non-performing loans per individual grantor of agent funds at the Bank level or a credit line - as follows:

The total monthly cost does not include VAT.

In addition to the regular monthly flat-sum cost, the Bank shall also invoice to the agent loan providers all other costs incurred in relation to legal actions for the said agent loans, to include the following: per diems, transportation costs, fuel and vehicle depreciation, court expenses, accommodation expenses and other expenses incurred in relation to an individual legal proceedings based on an agent loan.

VI. ACTUAL COSTS

The Bank retains a right to collect all actual costs incurred in relation to performance of other services not included in the said Fee tariff:

- Fees and charges collected by foreign and domestic banks participating in performance of certain deal/transaction;
- Duties, taxes, insurance premiums, etc. the Bank collects for the account or based on an order by a customer;
- Court expenses, legal representation costs, costs of appeals, enforcement costs, etc.
